Outputs Delivered: <ul style="list-style-type: none"> - The annual progress of PLGSP made in Province 2 in fiscal year 2020/21 was reviewed. - The Provincial Annual Strategic Implementation Plan (P-ASIP) of current fiscal year 2021/22 was discussed. Furthermore, the progress made in the first trimester was also reviewed by the Provincial Coordination Committee. - The proposed local governments for the implementation of some activities planned under outputs 6, 8, 9 and 10 were thoroughly discussed.

Methodology:

The Provincial Programme Director (PPD), Mr. Yam Prasad Bhusal welcomed the Provincial Coordination Committee (PCC) chaired by the Honorable Chief Minister and highlighted the objective of the PCC meeting. Governance cum Legal Expert, Ms. Punita Mandal made presentations on the annual progress made by the Provincial Programme Implementation Unit (PPIU) while the progress of Provincial Center for Good Governance (PCGG) was made by the Local Governance Expert, Mr. Arjun Kumar which was followed by discussions by the PCC members. Later, Ms. Punita Mandal made presentations on the Provincial Annual Strategic Implementation Plan (P-ASIP) of current fiscal year 2021/22 and also on the progresses made by PPIU and PCGG in the first trimester. The PCC members reviewed the progresses made and also discussed the PASIP.

The list of proposed Local Governments (LGs) for the e-attendance installation and commissioning (in 32 LGs) under PASIP activity 6.6; formulation of Revenue Improvement Action Plan (in 54 LGs) under PASIP activity 8.3; preparation of Capacity Development Plan (in 41 LGs) under PASIP activity 8.4; formulation of Periodic Plan (in 14 LGs) under PASIP activity 8.5; support 54 LGs to implement downward accountability tools and mechanism (public hearing, social audit) under PASIP activity 9.1; and organize orientation on Gender Responsive Budgeting for 50 LGs under PASIP activity 10.4 was also presented and discussed by the members in the meeting.










